Jonas Bergh has extensive experience in transactions, disputes/corporate investigations and outsourced business law, both in Sweden and internationally.

Jonas Bergh have been a partner in one of Sweden's law firms (Lagerlöf & Leman – today Linklaters), and founded and pursued own law business. He has also worked internationally in Brussels and as a partner in one of England's law firms (Ashurst).

Alongside the legal work Jonas has been a board member and chairman of the Board of Directors in listed and unlisted companies. He regularly acts as advisor to Boards and shareholders. He is also chairman of the board in a nomination committee of a listed company.
